Our carefully designed migration tool suite is designed to handle your data transition reliably and efficiently.

### **Applying Tools and Techniques for Successful, Seamless Data Migration**

IDS has created specific, unique data migration tools in parallel with our development of ProFinia, including built-in filtering that ensures valid data and relationships are maintained. We apply automated processes to simplify data migration, including basic data cleansing. Industry-standard data handling programs provide user control over data merging, ensuring data migration code is structured, modular and maintainable.

In your carefully planned data migration:

- Cross-reference tables direct and control the merging of data.
- Multiple databases can be migrated to ProFinia, in accordance with cross-reference tables that can be user-maintained as new needs arise.
- All data files are maintained in a standard format that allows full system flexibility.
- Users of systems other than InfoLease can map data to the same text file in a defined standard format, enabling migration through the same migration process and tools.

Whether we are migrating your data from InfoLease or from other software systems, our migration tools and expertise will handle a full range of data combinations. This tool set is separable by functional areas that can be easily included in, or excluded from the process, according to your business needs and goals. For over 25 functional areas, formal migration functionality is already in place, enabling automatic consolidation and mapping to the new system. Our entire approach is backed by the unmatched experience of IDS Professional Services in migrating data from many systems and platforms; this broad experience, applied to your migration project, ultimately mitigates risk and reduces time requirements.

Let's look more closely at the set of tools and processes we have established – and thoroughly tested -- to help you achieve accurate, efficient, and cost-effective data migration with minimal risk.

### **Tools for Data Extraction, Transformation, and Loading**

Whether you are migrating from InfoLease (which has basic data validation protocols built in) or another system, we will apply industry-standard Extraction, Transformation, and Loading (ETL) tools to properly condition and transfer your data. Our experience and expertise in applying such tools help guarantee that migrated data is properly conditioned for activation within ProFinia. However, we also allow for the possibility that you will wish to perform your own data extraction, in which case we can provide specific direction for formatting of the text files that result.

The first step in the data migration process is the automated extraction of data from your existing database(s) to a series of standardized text files. We have predefined these file structures for consistency across all our migration projects, and documented all procedures to ensure common understanding and communication between our project teams and yours.

IT professionals have used similar processes for years to exchange data between applications, and IDS Professional Services has a strong, deep history of performing these steps successfully for a wide range of companies. Major strengths include extensive knowledge of several standard database platforms, as well as server technologies and InfoLease. Using transitional temporary files provides a common starting point for the rest of the migration process, regardless of where the source data previously resided. These files provide a common structure for data coming from a standard InfoLease database, an InfoLease database with unique enhancements, user-defined fields from InfoLease, 3rd party leasing systems, or external files and spreadsheets. Many IDS clients have required the collapsing of multiple systems and data sets into new systems, and all our processes are designed to accommodate this requirement whenever necessary.

Once your data has been extracted and organized in standardized text files, it is ready for transformation and loading, the second step in the data migration process. This automated process converts data to the format ProFinia requires for full functionality. Note that this basic transformation, performed with an industry-standard ETL tool, does not include any recalculations or reconciliation. These steps are performed within ProFinia after loading to ensure the absolute integrity of your new system.

The transformation process restructures your data to enable the advanced functionality provided by ProFinia, including asset-centricity. It groups appropriate data fields for the ProFinia relational table structures, maintains and establishes required table and field relationships, and defines other fields as appropriate. These steps not only help simplify reconciliation, they enable you to begin gaining productivity immediately upon going live with ProFinia.

The transformation step also provides the opportunity to re-interpret your data for greater ease of use, or to update it for a better fit to your changing business. For example, if you have consolidated branches of your operations but not yet adapted your existing database to this change, this realignment will be readily performed in this data transformation phase of your migration. It is accomplished through the use of cross-reference tables, or “look-up” tables. These cross reference tables map the changes to be made and can be created in Microsoft Excel. Depending on your in-house resources and capabilities, these tables may be developed by you or by your IDS Professional Services team. In either case, the key is to apply mapping that accurately reflects your current desired business structure and processes.

Once data has been “transformed,” we load it into an industry-standard relational database and format it to suit ProFinia requirements. The data now resides within ProFinia – just as if it had been entered manually – but it has not yet been activated. At the heart of this loading protocol is the principle that data is “conditioned but not converted”; if the current system maintains data primarily at the contract level, it remains in that state until activation within ProFinia.

## **Data Activation and Synchronization within ProFinia**

For activation and synchronization of your data, we deploy a proprietary Java program – our *ProFinia Activation Manager* -- to apply additional unique, IDS-authored Java scripts and business rules. These programs and scripts leverage the power of advanced ProFinia routines to perform all steps in the activation of your data, including depreciation of assets and other key calculations.

We have carefully designed this process to exclude external calculations or modifications to the contract data outside of ProFinia. In the transformation and loading phase, the data was restructured for the new ProFinia database, and then was loaded to the ProFinia database, just as it would have been had you entered it manually. Rather than attempting to externally prepare, calculate and populate ProFinia’s database, ProFinia Java routines activate your agreement data, taking the lease or loan booking and performing all required calculations.

There is no risk of miscalculation where the migration calculations might not quite match ProFinia's asset-centric functionality, because those calculations are performed by ProFinia after the data was loaded to its database. The data will be represented as if you were to sit down and use ProFinia to bring the contract up to date by performing every button and click required to activate your entire portfolio of leases and loans, except that we have automated the process.

Our goal in devoting so much time and energy to the authoring and testing of these migration tools has been to get the same result you would achieve by entering all data manually and perfectly into ProFinia. Since all calculations from the entry of an asset or agreement throughout its life cycle --including all payment postings -- are performed within ProFinia, it is as if it had always been tracked through ProFinia. Reconciliation of your data is thus a one-time event -- it cannot "slip out of synch" due to data inconsistencies, and you can perform every necessary ProFinia function (even un-booking and rebooking agreements) without risk of error.

IDS has also developed a process to reconcile your migrated data between the source system and your new ProFinia database. There is no need to wonder if all of the right items have been checked, but only to follow the mapped process carefully. Another major advantage of our migration toolset is that it applies proven, tested processes, limiting reconciliation issues to those relating to custom or unique components of your migration.

### **Adding Key Functionality to What You Have Today**

In essence, you can retain the functionality you have and use today, *and enhance it with new functionality*, by choosing to migrate your current contracts to ProFinia-based agreements enabling access to asset-level functionality such as cash/payment application and payoffs. This approach can leave much of your user-viewed, agreement-level data intact, yet still enable the dramatic efficiency improvements that come with the solution's user-friendly interface and other advances. We have designed it to help you maximize your return on asset (ROA) through greater data control, better decisions, improved efficiency, and increased productivity.

Equally essential to the addition of powerful new functionality is seamless integration with your other business systems. IDS Professional Services will establish and quality-assure functional, reliable interfaces with your front-end lease/loan solution, General Ledger, collections, and other systems before you move into full production mode with ProFinia.

### **Delivery and Acceptance**

Delivery and Acceptance of your ProFinia-based solution involves several steps critical to the daily success of your business. We conduct *final* User Acceptance Testing (UAT) and provide training and standard training materials. Throughout the entire migration process, we test and reconcile your data numerous times to guarantee its integrity. We have designed our tools and processes to handle multiple data iterations, with the ability to refine your individualized processes with a minimum of new coding.

Such improvements might include refining processes not addressed within the migration, supporting new business functions, or addressing integration and Executive Information System needs. 
